PURPOSE ATTACHMENT TO THE
CERTIFICATE OF INCORPORATION
OF
THE KOTEL - WORLD'S PRAY CENTER INC.

The purposes are as follows:

- (i) To organize prayers at the Western Wall, at King David's tomb on Mount Zion and at holy sites in Jerusalem.
- (ii) To establish a synagogue and Beit Midrash and a center for hosting and distributing food and clothing to those in need.
- (iii) To organize bar mitzvah ceremonies at the Western Wall for needy boys.
- (iv) To provide training courses, conferences and lectures on Judaism and general peace in the world.
- (v) To solicit, accept, hold and invest, reinvest and administer funds exclusively for charitable, educational, religious purposes and to that end, to take and receive, by bequest, devise, gift or benefit of trust, and to purchase, construct upon or lease, any property, real, personal, tangible or intangible, wheresoever located and without limitation as to value.
- (vi) The Corporation is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.
